**SUPERSEDEAS INDICTMENT**

COUNT: I

Charge Code: 565.021-003Y19840999.0

The Grand Jurors of the County of Cole, State of Missouri, charge that the defendant, in violation of Section 565.021, RSMo, committed the class A felony of murder in the second degree, punishable upon conviction under Section 558.011, RSMo, in that on or about on or about October 25, 2018, in the County of Cole, State of Missouri, D.G. was killed by injuries sustained as a result of the perpetration of the class A felony of abuse or neglect of a child under Section 568.060, RSMo, and as a result of the perpetration of the class A felony of endangering the welfare of a child, committed by the defendant on or about October 25, 2018, in the County of Cole, State of Missouri.

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

COUNT: II

Charge Code: 568.060-001Y20133802.0

The Grand Jurors of the County of Cole, State of Missouri, charge that the defendant, in violation of Section 568.060, RSMo, committed the class A felony of abuse or neglect of a child, punishable upon conviction under Section 558.011, RSMo, in that on or about October 25, 2018,


in the County of Cole, State of Missouri, the defendant was eighteen years of age or older, and knowingly caused D.G., a child less than eighteen years of age, to suffer physical injury as a result of abuse by striking him and, the injury inflicted was serious physical injury on D.G. and D.G. died as a result of injuries sustained from this conduct. An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.


COUNT: III

Charge Code: 568.045-017Y20173802.0

The Grand Jurors of the County of Cole, State of Missouri, charge that the defendant, in violation of Section 568.045, RSMo, committed the class A felony of endangering the welfare of a child in the first degree, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or about October 25, 2018, in the County of Cole, State of Missouri, the defendant knowingly acted in a manner that created a substantial risk to the life, body and health of D.G., a child less than seventeen years of age, by inflicting serious physical injury and smothering him, and this offense resulted in the death of D.G.
